## SPECIAL PROVISIONS

WHEREAS, the undersigned "Subscriber" is in need of the Services and wishes to engage Opus VTR on the terms and conditions described in this Subscriber Participation Agreement and the Master Agreement.

By signing below, and by using the Services provided by Opus VTR Provided Services, "Subscriber", agrees to the following:

- I. Subscriber is responsible for all title and registration documentation until Opus VTR representative takes possession.
- II. If Subscriber's title and registration documents cannot be processed because of missing paperwork, errors or omissions, processing will be delayed until all requirements are met. Opus VTR will promptly notify Subscriber and use commercially reasonable efforts to assist Subscriber.
- III. Subscriber agrees to pay the fees and charges for Services as set forth in the Opus VTR Services Schedule and will be charged a fifty (\$50) service fee for any returned checks or ACH debits. All fees are payable at the time of service.
- IV. Refunds of state and local taxes and fees due to Subscriber will be subject to an Opus VTR administrative fee of \$50. Subscriber acknowledges and agrees to this administrative fee of \$50 to be charged by Opus VTR and deducted from all state and local refunds owed to subscriber. Opus VTR will not issue refunds for any state and local monies when the original refund amount is less than \$50.
- V. Subscriber agrees that the sole liability of Opus VTR or any of its agents or affiliates to Subscriber or any third party relating to the Services, including breach of the Provided Services, will be to provide corrections to any paperwork or processing errors resulting from the alleged breach and the limited warranties and remedies expressly provided in the Master Agreement, the terms of which are incorporated by reference.
- VI. Opus VTR will not be liable or deemed to be in default for any delay or failure to perform under this Agreement or for interruption of any Provided Service resulting, directly or indirectly, from any cause beyond Opus VTR's reasonable control, including the actions of any governmental authority.
- VII. To the extent that the terms of this Subscription Participation Agreement and the Master Agreement conflict, the terms of the Master Agreement shall control except as otherwise agreed by both Opus VTR and the Subscriber in writing in the Special Provisions section of this Subscription Participation Agreement. The terms of the Master Agreement are hereby incorporated into this Subscription Participation Agreement.
